### **What is the purpose of using images and sounds of my child/myself?**

Mother's Day Out may use photographs, videos, etc. of your child or you in promotional materials like pamphlets, recruiting videos, web sites, MDO newsletters, etc.

Mother's Day Out may also continue to photograph your child **without** your permission for school memories and class photographs.

### **Why do you want a release for my child/myself?**

The MDO wants you to be informed of our intent and possible use of photographs and videos that may contain images of you child or you.

### **Who does this apply to?**

We are asking for permission for children and parents. For example, at a MDO event, your picture may be taken. That photograph may then be put on the Mother's Day Out web site or our Facebook page for your enjoyment and for the world to see what Mother's Day Out is like.

### **Will I have my child's name or myself listed?**

Names will not be published with the photographs used by Mother's Day Out. However, faculty may have names listed.

### **Will the school profit from the photographs/sound/composition?**

The school might use the photograph of students in a pamphlet for MDO. We will not sell photographs/sound/compositions to agencies. This would be ONLY for MDO use and marketing promotion.

### **How long will this permission be valid?**

There would be no limit.

### **What if I refuse?**

We will not publish a photograph or use video of your child unless a parent or guardian signs this consent form.

### **What kind of information do you give out now and to whom?**

Currently, no information is given out unless it is to an appropriate agency or institution. For example, in case of medical emergency, it may be necessary to give your child's allergy information on file to the attending physician. No personal information is given out with photos.
